About the North Carolina Providers Council

The North Carolina Community Support Providers Council [doing business as The North Carolina Providers Council] was incorporated as a 501(C)(6) in 1997 in an effort to coordinate providers of mental health, intellectual/developmental disability, and substance use disorder services (MH/IDD/SUD). We recognize and believe that for ordered services to be effective in meeting people's needs, those services must be sufficient in amount, duration and scope, and that the rates paid to providers must also be sufficient to assure quality and continuity of care. Only by analyzing proposed legislative and regulatory changes can providers know how to advocate and inform General Assembly Members and administrative branch leaders.

The North Carolina Providers Council promotes the overall improvement of both the quantity and quality of community support necessary for individuals to remain in the community. The mission of this organization is:

Luncheon Keynote speaker Dr. Susan Mims of Dogwood Health Trust spoke about North Carolinians' health status.




- Direct Support Professional wage increases

- Mental Health Parity


2022 Legislative Outcomes:

The North Carolina General Assembly and Governor Cooper amended the biennium budget [S.L. 2022-74] in July of 2022. Several NCPC priorities were addressed in the Appropriations Act provisions:

- 9D.12: Authorization for a DSP wage study for both institutional and HCBS I/DD services;
- 9D.7. and 9D.13. modified Tailored Plan implementation contract requirements and implementation details.
- 9D.15 authorized the merging of NC Health Choice with Medicaid in 2023.
- 9K.3. Temporarily authorized Behavior Analysts (e.g., for RB-BHT for ASD services) to practice without supervision of a licensed psychologist.
