This bulletin is intended to serve as a <u>reminder</u> to LME/MCOs, providers and stakeholders about the implementation of the new and revised state-funded withdrawal management (detoxification) services and rates. These changes are being made in alignment with the Division of Health Benefits NC Medicaid 1115 SUD Demonstration Waiver. The new and revised state-funded withdrawal management services will be effective on May 1, 2024.

The 2024 State-Funded Enhanced Mental Health and Substance Use Services- 5-01-24 (<u>DMHDDSUS State-Funded Service Definitions</u>) document has been amended to remove the following services and all related references to these policies: Ambulatory Detoxification, Social Setting Detoxification, and Non-Hospital Medical Detoxification.
